Rules for the

Folleville ride event of May 31th and June 1st, 2014

The following rules apply to the Folleville ride event of May 31th and June 1st, 2014, organized by SOLEX MILLÉNIUM and to those persons having completed a signup form for these days.

- **Article 1:** The participant shall respect the entirety of the rules. Any breach of a single article will void any commitment of the organizers to the participant without refund of any kind.
- **Article 2:** Allowed mopeds: the event days are reserved for Solex and Vélosolex meeting original manufacturer standards regardless or their type of transmission.
- **Article 3:** Registration for this event is final and non-refundable even if the participant is a no-show.
- **Article 4:** Mandatory documents: the participant will be required to show proof of insurance and the registration card for the moped in question which shall be valid for the abovementioned dates.
- **Article 5:** A minor wishing to participate in the event will have to be in possession of a certificate of road safety (B.S.R.) as well as parental permission.
- **Article 6:** Verification check: Event organizers may do a moped safety check.
- **Article 7:** The ride: Participants shall present themselves to the organizers before the start of the ride with the mandatory helmet and adequate protective clothing in case of a fall. Any competition is prohibited.
- **Article 8:** *Instructions*: the participants must attend the instructions given by the organizers prior to departure.
- **Article 9:** Swap meet: Participants shall sell Solex bikes, or parts pertaining to Solex bikes and shall present all identity documents as requested.
- **Article 10:** Parking and riding: riding within the Folleville site shall be done at a reduced speed.
- **Article 11:** Damage / theft: The organizers will in no way be held responsible for damage and/or theft which may occur to parked vehicles in the course of the event.
- **Article 12:** Rules: This event will take place in a friendly manner and participants are invited to respect the friendly spirit thereof. By attending, each participant accepts without reservation all articles and rules set forth by the organizers.
